- 6. No mobilization advance shall be given by GMDC for this contract
- 7. All the rates quoted by the Tenderer must be inclusive of all required materials.
- 8. Payment will be made after satisfactorily completion of the whole work after measuring the area covered.

- 9. If the tenderer has already been blacklisted by any Government/ Government Undertakings/ Co-operative societies, his tender will be rejected. In case information about such black listing comes to the knowledge of the Union after awarding of the tender, the contract will be terminated, liquidated damages levied, apart from taking penal action.
- 10.BCMPUL reserves the right to accept or reject any or all tender wholly / partly without assigning any reason thereof.
- 11. Successful bidder has to complete the work in two phases within 15 days.
