- 3. Quotation shall only be accepted in sealed envelope subscribing the Enquiry No. and Item Type. No quotations shall be accepted through mail. Incomplete quotations are liable to be rejected.
- 4. Price quoted by the bidder should be inclusive of all taxes levies packing, and forwarding F.O.R The Bhagirathi Cooperative Milk Producers' Union Limited. No escalation in price will be considered after submission of bids.
- 5. The bidders participating in the quotation are requested to provide GST Registration Certificate along with the price bids. If you an unregister dealer, GST amount would be deducted from your bill.
- 6. Time being the essence of contract the job must be completed within 7 days after placement of Work cum Supply Order.
- 7. Penal Clause: Liquidated Damage of 0.5% of the total cost shall be charged if there is any delay in completion of the job subjected to a maximum of 10% of the total cost and the amount shall be recovered from the bills. If the Milk Union makes alternative arrangements due to negligence of the party, the cost of the contract arranged from the different source shall be deducted from the party.
- 8. Payment shall be made in NEFT/RTGS within 20 days after satisfactory completion of the job certified by competent authority.
- 9. If the material received is found faulty or possess any manufacturing defect as a result of poor workmanship within a month or two then it has to be replaced by the party.
- 10.In case of any dispute between the Milk Union and the bidder the decision of the Milk Union shall be binding.
- 11. The Milk Union reserves full right to accept or reject any quotation/all quotations or to cancel the entire process without assigning any reason thereof.
