Eligibility Criteria & Mandatory Documents:

1. **Statutory documents:** Bidder shall submit latest GST Registration Certificate, copy of valid PAN Card.

All the above-mentioned criteria and documents are mandatory and if the bidder fails to submit any of them, their bid will summarily be rejected.

Submission of bids: The bids will be submitted in offline mode.

Technical bid submission:

The entire mandatory documents namely

- 1. GST Registration Certificate
- 2. Copy of valid PAN Card

Shall be placed in a sealed cover having written on top "NIT for Procurement of Aluminum Alloy Milk Can Lid for 40Ltrs. Capacity.".

Both the sealed covers of Technical and Financial bid shall be placed in another bigger sealed cover having written on its top as "BID for **NIT for Procurement of Aluminum Alloy Milk Can Lid for 40Ltrs. Capacity.**".

The bid shall be submitted in The Bhagirathi Cooperative Milk Producers' Union Limited.

Validity of the bid: The bid once submitted will be valid for 60 days.

Delivery Period: The selected bidder shall deliver the materials within 30 days from the date of acceptance Purchase Order.

Other Terms & Conditions:

- 1. The bidders are required to submit their tender before last date and time of submission. No bids will be accepted for evaluation after last date and time of bid submission.
- 2. Partial/incomplete tenders are liable to be rejected. The tender documents should be properly indexed and signed and sealed by the bidder.
- 3. Price quoted by the bidder should be inclusive of all taxes levies, Insurance, packing, forwarding and transportation charges & FOR dairy.
- 4. Time being the essence of contact, materials must be delivered within 30 days after placement of Supply Order.
- 5. Penal Clause: Liquidated Damage of 0.5% of the total cost shall be charged if there is any delay in supply of goods subjected to a maximum of 10% of the total cost and the amount shall be recovered from the bills. If the Milk Union makes alternative arrangements due to negligence of the party, the cost of the consignment arranged from the different source shall be deducted from the party.
- 6. Force Majeure: For delay in supply of goods for which neither the supplier or the Milk Union is responsible like strikes, lockouts, war, catastrophe shall be termed as "Force Majeure" and penalty clause will not be applicable.
- 7. Payment will be made in NEFT/RTGS after 20 days after delivery of goods and receipt at the Store Section of the Milk Union in good condition followed by submission of bills. The bank details of the party are to be mentioned in the bills clearly.
- 8. The Requisitioning Authority will certify the quality of goods received at the store. In case if material is not conforming prescribed specification and quality, penalty shall be imposed and the cost will be deducted from the bill accordingly.
- 9. In case of any dispute between the Milk Union and the bidder the decision of the Milk Union shall be binding.
- 10. The Milk Union reserves the right to cancel the Order if the Supplier fails to supply the goods in due time or compromises with the quality of the goods.

The Managing Director of The Bhagirathi Cooperative Milk Producers' Union Limited reserves the right to reject or cancel any bid without assigning any reason whatsoever.
