Sealed quotations are invited from bonafide and reputed contractors or suppliers for supply of packaged drinking water of reputed brand (20L Jar) with hygienic and authentic water branding along with original valid seal for a period of **one year w.e.f 1st August, 2025** to the different sections of The Bhagirathi Cooperative Milk Producers' Union Limited (hereinafter referred to as the "Milk Union"), Feeder Dairy, Panchanantala, Berhampore, Murshidabad, WB-742101 on daily basis. Rates per jar shall be inclusive of all charges including carrying and delivery cost. The NIQ shall be valid for a period of three years.

BID SYSTEM:

1. Technical Bid (Eligibility):

The following documents are required to be submitted along with the financial bid offered:

- a. Valid Trade License (photocopy)
- b. PAN (Photocopy)
- c. Aadhaar (Photocopy)

2. Financial Bid (Price Bid):

It shall contain the rate at which the supplier is willing to supply the packaged drinking water with 20L jars and will accept all the terms & conditions stipulated in this NIQ. The Rate has to be quoted in **Annexure-A** prescribed hereafter.

GENERAL TERMS AND CONDITIONS:

1. The bidder/service provider shall have to ensure the supply of pure drinking water with 20 liters of sealed jar as per our requirement. Quantity may vary based on our demand and payment will be made on actual quantity supplied to us with the rate as scheduled above.
2. It shall be filled in sealed containers suitable for direct consumption without further treatment which must be a branded and reputed company.

3. The ingredients used shall be food grade quality and confirm to the requirements of the Prevention of Food Adulteration Act, 1954 and the rules framed thereunder.
4. The production house/ unit of the packaged drinking water must be guided as per FSSAI norms.
5. The bidder/service provider shall personally and solely be responsible for any consequences due to supply of unhygienic water or any adulteration with or without chemical or biological ingredients.
6. The container charge for 20L jar shall not be incurred by the Milk Union and the bidder has to collect the empty jars from the different sections in his/her own arrangement.
7. Payment will be made on satisfactory supply of pure drinking water in the segments of various section as per our requirement and within 7 days after submission of your original bills duly certified by the user sections. No escalation in price / rate will be allowed on any ground and no mobilization advance shall be given to you for this purpose.
8. Bhagirathi Milk Union reserves the right to cancel the Supply Order without assigning any reason thereof and in any time without providing prior notice.

SELECTION PROCESS:

The lowest rate offered (L1) amongst the qualified bidders shall be considered and selected for issuance of award of contract subject to the approval of the undersigned.
