NOTICE INVITING E-TENDER

The Bhagirathi Cooperative Milk Producers' Union Limited invites Online Tender (E-Tender) in two bid system of Annual Rate Contract for providing Pest Management Services at different units of Bhagirathi Milk Union namely Feeder Dairy, Kandi Chilling Plant, Domkal Chilling Plant.

| Earnest Money Deposit | The EMD amounting to Rs. 9,999/- should be deposited online through Net Banking, NEFT/RTGS in favour of The Bhagirathi Cooperative Milk Producers' Union Limited payable at Berhampore. EMD shall not carry interest. Tenderers will select the Tender to bid and initiate payment of pre-defined EMD for that tender by selecting from either of the following payments modes (vide Finance Department Memorandum no. 3975-F(Y) Dt. 28/07/2016): | | |

- 1. Net banking (any of the banks listed in the ICICI Bank Payment gateway) in case of payment through ICICI Bank Payment Gateway.
- 2. RTGS/NEFT in case of offline payment through bank accounts in any Bank.

Payment procedure

- a) Payment by Net Banking (any listed bank) through IClCI Bank Payment Gateway:
- 1. On selection of net banking as the payment mode, the bidder will be directed to IClCI Bank Payment Gateway webpage (along with a string containing a Unique ID) where he will select the Bank through which he wants to do the transaction.
- 2. Bidder will make the payment after entering his Unique ID and password of the bank to process the transaction.
- 3. Bidder will receive a confirmation message regarding success/failure of the transaction.
- 1. If the transaction is successful, the amount paid by the bidder will get credited in the respective Pooling account of The Bhagirathi Cooperative Milk Producers' Union Limited maintained with the Focal Point Branch of IClCI Bank at R.N. Mukherjee Road, Kolkata for collection of EMD/Tender Fees.
- 2. For transaction failure, the bidder will again try for payment by going back to the first step.

b) Payment through RTGS/NEFT:

- 1. On selection of RTGS/NEFT as the payment mode, the e-Procurement portal will show a pre-filled challan having the details to process RTGS/NEFT transaction.
- 2. The bidder will print the challan and use the pre-filled information to make RTGS/NEFT payment using his Bank account.
- 3. Once payment is made, the bidder will come back to the e-Procurement portal after expiry of a reasonable time to enable the NEFT/RTGS process to complete, in order to verify the payment made and continue the bidding process.
- 4. If verification is successful, the fund will get credited to the respective Pooling account of The Bhagirathi Cooperative Milk Producers' Union Limited maintained with the Focal Point Branch of ICICI Bank at R.N. Mukherjee Road for collection of EMD/Tender Fees.
- 3. Hereafter, the bidder will go to e-Procurement portal for submission of his bid.
- 4. But if the payment verification is unsuccessful, the amount will be returned to the bidder's account.

B. Refund/Settlement Process:

i. After opening of the bids and technical evaluation of the same by the Quotation inviting authority through electronic processing in the e-Procurement portal of the State Government, the Quotation inviting authority will declare the status of the bids as successful or unsuccessful which will be made available, along with the details of the unsuccessful bidders, to IClCI Bank by the e-Procurement portal through web services.

ii. On receipt of the information from the e-Procurement portal, the Bank will refund, through an automated process, the EMD of the bidders disqualified at the technical evaluation to the respective bidders' bank accounts from which they made the payment transaction. Such refund will take place within T+2 Bank Working Days where T will mean the date on which information on rejection of bid is uploaded to the e-Procurement portal by the Tender inviting authority. iii. Once the financial bid evaluation is electronically processed in the e Procurement portal, EMD of the technically qualified bidders other than that of the L1 will be refunded, through an automated process, to the respective bidders' bank accounts from which they made the payment transaction. Such refund will take place within T+2 Bank Working Days where T will mean the date on which information on rejection of financial bid is uploaded to the e-Procurement portal by the Quotation inviting authority. iv. If the L1 bidder accepts the LOI and the same is processed electronically in the e-Procurement portal and the information on Award of Contract (AOC) to the L1 bidder is uploaded to the e-Procurement portal by the tender inviting authority. v. As soon as the Ll bidder is awarded the contract (AOC) and the same is processed electronically in the e-Procurement portal – a) EMD of the L1 bidder for tenders of State Government offices will automatically get transferred from the pooling account to the State Government deposit head "8443-00-103-001-07" through GRIPS along with the bank particulars of the Ll bidder. b) EMD of the L1 bidder for tenders of the State PSUs/Autonomous Bodies/Local Bodies/PRIs, etc will automatically get transferred from the pooling account to their respective linked bank accounts along with the bank particulars of the L1 bidder. In both the above cases, such transfer will take place within T+1 Bank Working Days where T will mean the date on which the Award of Contract (AOC) is issued. vi. The Bank will share the details of the GRN No. generated on successful entry in GRIPS with the E-Procurement portal for updation. vii. Once the EMD of the Ll bidder is transferred in the manner mentioned above, Tender fees, if any, deposited by the bidders will be transferred electronically from the pooling account to the Government revenue receipt head "0070-60-800-013-27" through GRIPS for Government tenders and to the respective linked bank accounts for State PSU/Autonomous Body/Local Body/PRIs, etc tenders. viii. All refunds will be made mandatorily to the Bank A/c from which the payment of EMD (if any) were initiated. **Bid Document** The bid document is available in the E-Tendering Portal of Govt. of West Bengal https://wbtenders.gov.in. **Technical Bid Evaluation** The Technical Bid will be evaluated by the Tender Committee. Bidders shall upload all the necessary documents in the Technical Folder which will be verified and evaluated by the Tender Committee. **Financial Bid** Rate shall be quoted in the Financial bid The bidder shall quote the rate online through Computer only in the space marked for quoting rate in the Bill of Quantities (BOQ). Only downloaded copies of the above documents, digitally signed by the bidder are to be uploaded (Excel file).

Scope of Work:

- 1. Total Pest Rodent and Snake and Control management in Feeder Dairy (Dairy, Office and Store Campus), Kandi Chilling Plant and Domkal Chilling Plant.
- 2. Eradication of Cockroaches, Mosquitoes, Flies, Lizards, spiders, cobwebs, rats, snakes etc. through permitted insecticides by applying non toxic chemicals with specific formulation suitable for Dairy and Food Industries and timely removal and disposal of killed pests as per Government of India and WHO norms. All the areas specified by the BCMPUL must be covered.
- 3. In case of complaints, additional effective treatment must be given at no extra cost within 24 hours on receipt of intimation from our end.
- 4. If the total number of complaints for ineffective treatment at one or more places exceeds three during the contract period, a penalty of Rs.200.00 will be imposed for each complaint after the first three complaints.
- 5. The contractor will maintain job cards against each area and obtain signature of our In-charge (Quality Control) or In-Charge Dairy/Maintenance after each treatment and the same shall also be produced for our verification whenever needed.
- 6. Disinfection of plant and office building should be done using approved non-toxic insecticides suitable for Dairy Industries.
- 7. Lowest successful bidder must ensure that the pest control once done shall remain effective up to next pest control failing which it shall have to be done again without anycost.
- 8. Lowest successful bidder must ensure that food ingredients, milk and milk products are not contaminated by the use of insecticides/pesticides or chemicals.

General Terms & Conditions

- 1. It is a two part bid which consists of Technical & Financial bid separately. The applicants mustupload the credentials Statutory & Non Statutory documents in the Technical Folder. Technical & Financial quote must not be sent through post / physically. Bhagirathi may physically verify documents if required.
- 2. The intending bidders are required to quote the rate online only. Financial Bid will contain rate of items only. No other document will be sent in the financial bid (Folder).
- 3. Price quoted by the bidder should be inclusive of all taxes levies packing, forwarding, transportation and any other incidental charges & FOR Feeder Dairy Berhampore.
- 4. EMD of successful bidder shall be converted to security deposit. EMD of unsuccessful bidders shall be refunded. EMD shall not carry any interest. The EMD which has been converted to Security Deposit shall be released after 12 month of successful execution of the Contract.
- 5. Security deposit shall be forfeited if the successful bidder does not comply with the terms and conditions of the contract or does not provide satisfactory performance as certified by In- Charge Dairy.
- 6. Any delay in disbursing the services by the successful bidder as mentioned in the tender shall attract penalty and shall be deducted from the monthly bills.
- 7. Bidders should take sufficient care to ensure that the chemicals used for this job do not contaminate (whether intentionally or not) milk and milk products.
- 8. All chemicals used for the service within the processing plant shall be food grade, odour-less and eco-friendly.
- 9. The Bidders are requested to visit the premises and acquaint themselves fully about thearea for which the works are to be carried out before quoting the rates. Quoting minimum rate just for acquiring the tender will not be the only criteria for award of the contract. Therefore, Bidder should carefully assess the work before offering the rates.
- 10. Payment will be made in NEFT/RTGS after 30-45 days in monthly basis after satisfactory service from the party certified by In-Charge Dairy/Quality Control followed by submission of bills. The bank details of the party are to be mentioned in the bills clearly.
- 11. In case of any dispute between the Milk Union and the bidder the decision of the Milk Union shall be binding.
- 12. The Milk Union reserves the right to cancel the Contract if the Supplier fails to execute the job. On termination of contract the security deposit shall be forfeited.
- 13. The Milk Union reserves the right to accept or reject any tender/all tenders or to cancel the entireprocess without assigning any reason thereof.
