General Terms & Conditions:

1. Interested parties are required to go through the Terms & Conditions carefully, understand the requirement, inspect the site and then quote the most competitive rate in sealed envelope addressed to the Managing Director, The Bhagirathi Cooperative Milk Producers' Union Limited, Feeder Dairy, Panchanantala, Berhampore, Murshidabad, 742165 (WB).
2. Quotation shall only be accepted in sealed envelope subscribing the Quotation Reference Number. No quotation shall be accepted through mail. Incomplete quotations are liable to be rejected.
3. **Validity of the Offer:** The offer once submitted will be valid for 120 days from the last date of submission as specified in this Notice.
4. Address of the interested party should be within district. Address proof of bidder must be provided along with quotation.
5. The bidder participating in the quotation must provide GST Certificate.
6. Bidder should furnish make and model number of cameras.
7. Bidder should be authorized dealer/supplier/service provider of Cameras. Authorization Certificate must be furnished along with the quotation.
8. Site Inspection must be done and report duly signed from Milk Union must be submitted along offer.
9. **Payment:** 90% payment shall be made in NEFT/RTGS within 45 days after successful completion of the contract. Remaining 10% shall be released after 2 year. This remaining 10% shall serve as **Performance Guarantee**.
10. **Time of Completion:** Time is the essence of the contract. Date of commencement shall be either one-week from the date of issue work order or the day on which the contractor will take possession of site, whichever is earlier. The work shall be completed within 7 days from the date of commencement of the job.
11. **Liquidated damages:** Liquidated damages @ 0.5% of the total cost of the contract per week shall be deducted from the contractor subjected to a maximum of 10% of the total cost if there is any delay in completion of the work attributed to the contractor. Any habitual delay beyond the specified time of completion of the job shall lead to the termination of contract and forfeiture of Security Deposit.

12. **Quoted Price:** As per Annexure-A. Rate should be inclusive of all taxes and levies. No other incidental charges shall be applicable after submission of offer.
13. **Site Inspection: Rates quoted without site inspection shall not be accepted at any cost.**
14. **Quantity of Job: The quantities of various items given in the schedule of quantities are approximate. The quantities of work may vary at time of allotment/execution of work. BCMPUL reserves the right to omit/delete any item(s) of work from the schedule at the time of allotment/execution of work. Contractor will be paid for the actual work done at the site duly verified by the concerned official of the Milk Union.**
15. **Defect liability period:** The Defects Liability Period shall be for a period of two year and shall commence from the date of completion of the job. Any defect that may appear within the Defects Liability Period, shall be rectified by the Contractor without any extra cost to the Tenderer. In case of failure to do so within 10 days from such notice from the Milk Union, the Milk Union may get such rectification works carried out through any other firm and expenditure incurred by the BCMPUL shall be recovered from any money due to the Contractor at the cost and risk of the contractor. Only, after all the defects pointed out during the Defects Liability Period have been satisfactorily rectified by the Contractor will the release of the Performance Guarantee. In addition to the calls received by the Milk Union, the contractor will have to make compulsory visits for checking the system and for preventive maintenance for 2 years.
16. **Storage at site:** Storage space may be allowed at site as per the availability. The Contractor will have to make his own arrangement for security and locking arrangement of the storage space. The Contractor may be required to vacate the storage space as per exigency of BCMPUL without any extra cost.
17. **Sub-standard work and material:** If any work or material used at site is found to be unsound, imperfect or inferior from what is specified in the contract, the Contractor shall be advised to rectify or re-execute the work or remove the material as the case may be, within a reasonable time depending upon the nature of work. If the Contractor fails to do so, the work shall be got redone or rectified or the material replaced through any other agency at the risk and cost of the Contractor.
18. **Safety Measures:** During-the execution of works, every care shall be taken to ensure that the safety and convenience of workmen staff, authority visitors to site and the public are duly catered to and that all operations are carried out in such a manner as to cause least interference with the traffic or ordinary pursuit of the people.
19. **Warranty:** All items shall cover warranty of 24 months from the date of commissioning of the system.

20. **Support:** Call must be attended immediately and any problem regarding maintenance whether it requires change of spares or technical support must be resolved within 24 hours. In case the problem is likely to get longer period to get resolved it must be communicated to the Milk Union. If the complaint is not resolved within 24 hours, the penalty of Rs. 500 per 24 hours will be applied.
21. **Warranty Extension:** If any device is down for more than a week its warranty shall be extended by 1 month. If any device is down for more than 1 month its warranty shall be extended by 1 year.
22. **Documentation:** Supplier must provide manual of devices quoted. Supplier must submit Network Diagram along with invoice and mark the cables accordingly.
23. **Training:** The contractor shall provide training which is required by a personnel to operate and maintain the CCTV Surveillance system.
24. **Preventive Maintenance:** Preventive Maintenance along with proper log record is to be carried out on quarterly basis by your service technician for a period of 2 years. Preventive Maintenance shall comprise of removing dust and debris along the network. Cleaning of cameras, removal of rusts. Cleaning network nodes and internodes along with voltage and earthing checkup. The voltages and earthing values are to be recorded in the register kept in the custody of the Milk Union.
25. If the material received is found faulty or possess any manufacturing defect as a result of poor workmanship during warranty period it has to be replaced by the party.
26. In case of any dispute between the Milk Union and the bidder the decision of Milk Union shall be binding.
27. **The Managing Director reserves full right to accept or reject any quotation/ all quotation or to cancel the entire process without assigning any reason thereof.**
