General Terms and Conditions:

- 1. The bidders are required to go through the Terms & Condition carefully, understand the requirement and then quote the most competitive rate in sealed envelope addressed to the Managing Director, The Bhagirathi Cooperative Milk Producers' Union Limited, Feeder Dairy, Panchanantala, Berhampore, Murshidabad, 742101 (WB).
- 2. Quotation shall only be accepted in sealed envelope subscribing the Enquiry No. and Item Type. No quotations shall be accepted through mail. Incomplete quotations are liable to be rejected.
- 3. Price quoted by the bidder should be inclusive of all taxes levies packing, and forwarding F.O.R The Bhagirathi Cooperative Milk Producers' Union Limited and in adherence to the payment terms and other general terms and conditions enshrined in this NIQ. No escalation in price will be considered after submission of bids.

- 4. The bidders participating in the quotation must provide the following Mandatory Documents along with the price bids:
 - a. Copy of NIQ duly signed and Sealed as a token of acceptance of all terms and conditions in the NIQ.
 - b. GST Registration Certificate / Unregistered dealers may also participate but the GST amount will be deducted from the bill amount if applicable.
 - c. Rate as per format in FORMAT A.

Failure to submit the above mandatory documents shall lead to rejection of the Quotation.

- 5. The rate quoted in the bid is fixed for the Tenure of Contract and there shall be no variation in rate whatsoever and no claims regarding escalation of rates will be entertained during the contract period.
- 6. Spare Parts will be provided by the Union on advance intimation.
- 7. Regular attendance in the night shift to be kept separately and to be submitted along with the bill. In case of failure, pro-rata deduction will be made.
- 8. The job must be completed within 7 days after placement of Order.
- 9. Payment shall be made in NEFT/RTGS within 30 days after satisfactory completion of the job certified by competent authority.
- 10. In case there is any discrepancy in quality of job the Milk Union may impose a penalty. In this case prior intimation shall be given to the supplier.
- 11. Please note that during contract period if your work is not found satisfactory, we may discontinue the AMC without assigning any reason thereon.
- 12. In case of any dispute between the Milk Union and the bidder the decision of the Milk Union shall be binding.
- 13. The Milk Union reserves full right to accept or reject any quotation/all quotations or to cancel the entire process without assigning any reason thereof.
