EMD is exempted for MSME industries. 2. The bidder will print the challan and use the pre-filled information to make RTGS/NEFT payment using his Bank account.

3. Once payment is made, the bidder Will come back to the e-Procurement portal after expiry of a reasonable time to enable the NEFT/RTGS process to complete, in order to verify the payment made and continue the bidding process.

4. If verification is successful, the fund will get credited to the respective Pooling account of The Bhagirathi Cooperative Milk Producers' Union Limited maintained with the Focal Point Branch of ICICI Bank at R.N. Mukherjee Road for collection of EMD/Tender Fees.

3. Hereafter, the bidder will go to e-Procurement portal for submission of his bid.

4. But if the payment verification is unsuccessful, the amount will be returned to the bidder's account.

B. Refund/Settlement Process:

i. After opening of the bids and technical evaluation of the same by the Quotation inviting authority through electronic processing in the e-Procurement portal of the State Government, the Quotation inviting authority will declare the status of the bids as successful or unsuccessful which will be made available, along with the details of the unsuccessful bidders, to ICICI Bank by the e-Procurement portal through web services.

ii. On receipt of the information from the e-Procurement portal, the Bank will refund, through an automated process, the EMD of the bidders disqualified at the technical evaluation to the respective bidders' bank accounts from which they made the payment transaction. Such refund will take place within T+2 Bank Working Days where T will mean the date on which information on rejection of bid is uploaded to the e-Procurement portal by the Tender inviting authority.

iii. Once the financial bid evaluation is electronically processed in the e Procurement portal, EMD of the technically qualified bidders other than that of the L1 and L2 bidders will be refunded, through an automated process, to the respective bidders' bank accounts from which they made the payment transaction. Such refund will take place within T+2 Bank Working Days where T will mean the date on which information on rejection of financial bid is uploaded to the e-Procurement portal by the Quotation inviting authority. However, the L2 bidder should not be rejected till the LOI process is successful.

iv. If the L1 bidder accepts the LOI and the same is processed electronically in the e-Procurement portal, EMD of the L2 bidder

Brief Description of Scope of Work

The Contractor/Service Provider shall be responsible for loading, unloading, shifting, and stacking of goods, cleaning floor space with clearance of debris. The scope of Work along with Tentative Requirement per month is as follows:

General Terms & Conditions

1. Two part bid which consists of Technical & Financial bid separately.
2. The applicants must upload the Statutory & Non Statutory documents in the Technical Folder. Nothing should be sent physically.
3. Milk Union may seek clarification of rate quoted in the tender during bid evaluation.
4. Subletting is strictly prohibited and shall lead to disqualification of the bidder. The bidder shall also be subsequently blacklisted for 3 years.
4. EMD of the lowest successful bidder shall be converted to Security Deposit and shall be released after successful execution of the contract. EMD shall not carry any interest.
5. **Rate Escalation:** The rate quoted by the bidder will be fixed. No escalation in the rate of the above materials would be considered during the contract period whatsoever.
6. **Quantity of Goods:** Quantity of goods as mentioned is tentative. Actual quantity may vary depending upon business requirements.
7. **Terms of Payment:** Payment shall be made in NEFT/RTGS on monthly basis subject to presentation of 3 copies of bills detailing the service rendered duly certified by the Concerned Sectional In-Charge and approved by the Competent Authority.
8. **Loading & Unloading Time & Place:** Loading and Unloading shall be from 09:00 am to 09:00 pm at Feeder Dairy Berhampore, Chilling Plant at Kandi, Chilling Plant at Domkal. 1 MT of item should be unloaded and stacked in 10 minutes. Unloading and stacking of goods must be done in a reasonable time.

9. **Liquidated Damage:** Time being the essence of contract no variation shall be permitted in the unloading time as prescribed in the NIT. If the bidder fails to supply and execute the work in time then the Milk Union Ltd. shall reserve the right to impose penalty (@ Rs. 300/- per day)/cancel the order/contract besides forfeiture of Security Deposit. If the Milk Union makes alternative arrangement for Loading & Unloading of goods due to failure of the contractor/service provider, the extra cost if any shall be deducted from the bills of the contractor.
10. **Penal Provision:** One termination of contract, the Security Deposit is liable to be forfeited and any of the resultant loss beyond Security Deposit will be recovered from the contractor by legal means apart from forfeiture of any amount due to the contractor.
11. **Maintenance of ethical Standard in Business:** Suppliers shall maintain ethical standard in business. Contract may be terminated if there is lack of ethical standards from the party. Dishonesty shall be strictly prohibited.
12. The Contractor must follow safety and security rules as prevalent in industry.
13. **Dispute Resolution** Any dispute arising out of the Agreement, which cannot be amicably settled between the parties, shall be referred to adjudication/arbitration in accordance with the Arbitration and Conciliation Act of 1996 of India. The venue of adjudication/arbitration shall be Kolkata. The language of arbitration shall be English.
14. **Applicable Law:** The Agreement shall be interpreted in accordance with the laws of Union of India.
15. **Force Majeure:** If, at any time during the subsistence of this contract, the performance in whole or in part by either party of any obligation under this contract is prevented or delayed by reasons of any war or hostility, act of public enemy, civil commotion, sabotage, fire, floods, explosion, epidemics, quarantine restriction, strikers lockout or act of God (hereinafter referred to as events) neither party shall have any claim for damages against other in respect of such non-performance or delay in performance.
16. The Milk Union reserves the right to cancel any bid at any point of time or to cancel the entire tender at any point of time without assigning any reason thereof.
17. In case of any dispute between the supplier and the milk union, the decision of the Milk Union shall be final and binding.
