### **Payment Terms & Conditions:**

The highest auctioneer/proposer will have to pay the entire bid value within February, 2025 on acceptance of award of contract failing which contract will be terminated automatically and subsequently the security amount will be forfeited

### **Other Terms & Conditions for Tender Auction**

- 1. Any conditional Tender will not be entertained and will be rejected.
- 2. The tenderer or his/her authorized person may inspect the site and its surrounding areas and obtain for himself on his own responsibility all information that may be necessary for preparing of the bid and entering into the contract.
- 3. If the tendered rates are found unjustified, it may not be accepted.
- 4. The tenderer/bidder should mark his signature in the bidding paper, without which the bid is liable to be rejected.
- 5. The sealed tender should reach this office by speed post/Courier service or by Hand before the last date and time of submission as scheduled above. The Bhagirathi Milk Union will not be responsible for any postal delay. Tenders received beyond the last date and time will be summarily rejected.
- 6. Bidders/tenderers are at liberty to be present or authorize a representative to be present at the time of opening of tenders.
- 7. The Bhagirathi Milk Union reserves the right to accept or reject any of bids without assigning any reason thereof.
- 8. After qualifying the technical bid evaluation, the auctioneer proposing highest amount of bid as per financial bid evaluation, will be selected for award of contract.
- 9. An amount of Rs.10,000/- will be deposited as Security amount either in cash or through bank draft in favour The Bhagirathi Cooperative Milk Producers' Union Ltd. payable at UBI, Bhagirathi Branch within 3 days from the date of acceptance of award of contract
- 10. Any Tax if applicable shall have to be paid by the successful bidder.
- 11. Firewood should not be used for cooking etc. in the campus. If any worker is found doing so, the contractor will have to pay the penalty fixed by the Milk Union.
- 12. The Contractor will be required to intimate the name of the person with the full address and photocopy of identity for entering into the campus. Milk Union will not bear any cost on account of wages or others to the workers to be deployed by the contractor.
- 13. The contractor or his staff shall not indulge in any act which may hamper the peace or serenity of the campus, likely to be detrimental to the interests of the Milk Union.
- 14. After execution of contract, the contractor hereby grants to use the said orchard as an "as is where is and whatever there is" condition basis.
- 15. The contractor shall not assign, transfer, sublet or part with the possession of the said orchard or any portion thereof to any other person without the prior written consent of the Milk Union.

- 16. The contractor shall be exclusively responsible for the safekeeping and risks of the products and shall take out adequate safety/security measures for the same. The Milk Union shall not in any manner be responsible for any loss, theft, pilferage or damage to any product of the contractor under any circumstances whatsoever nor shall the Milk Union be responsible for any injury or death caused due to orchard to any person of the contractor or under the contractor under any circumstances. The contractor hereby indemnifies and shall continue to indemnify the Milk Union from all claims, suits, costs, expenses, liabilities, losses or damages that may arise during the period of the contract and up to the date and time of returning back the vacant and peaceful possession of the said orchard back to the Milk Union.
- 17. The Milk Union shall also have the right to check the orchard at any time in question to ensure that the terms of this agreement are complied with or to comply with any law or protect the interest of the Milk Union in any manner. Further, it is expressly understood by the contractor that the constructive possession shall always rest with the Milk Union.
- 18. At any time during the period of this contract, the Milk Union shall have the option to terminate this contract by giving prior notice without assigning any reasons and the contractor shall stand terminated accordingly.
- 19. The contractor shall not at any time put any claim of ownership, lease, sublease, tenancy or sub tenancy or any other right or title in the said orchard and this contractt shall not be constructed to create any such right whatsoever in favour of the contractor.
- 20. The contractor shall handover peaceful possession of the said orchard in same condition subject to normal wear and tear to the Milk Union after expiry of this contract or expiry of its renewal period or earlier termination whichever is earlier as the case may be without any hindrance, demur or encumbrance.
- 21. The contractor shall comply with the provisions of all the applicable labour laws, particularly Acts and any amendment/modifications thereto or any other law relating thereto and Rules made there under from time to time and comply with all provisions applicable therein and / or make all the payments specified therein. The Act includes and amendments and rules framed therein from time to time.
- 22. The contractor shall not carry out any structural alterations or additions or changes in the said orchard without the prior consent of the Milk Union.
- 23. In case of any dispute of difference between the parties the Milk Union shall amicably try to resolve the same; If the matter fails to be resolved the same shall be referred to a Sole Arbitrator to be appointed by the Milk Union.
- 24. The successful tenderer/bidder would be responsible for maintenance of the auctioned plants. All the operations including manuring, watering, weeding, pruning, insect-pest management, bird scaring, guarding, harvesting and transportation will be carried out by the successful bidder at his/her own cost.
- 25. In case of any dispute of difference between the parties the Milk Union shall amicably try to resolve the same; If the matter fails to be resolved the same shall be referred to a Sole Arbitrator to be appointed by the Milk Union.
