B. Refund/Settlement Process:

After opening of the bids and technical evaluation of the same by the Quotation inviting authoritythrough electronic processing in the e-Procurement portal of the State Government, the Quotationinviting authority will declare the status of the bids as successful or unsuccessful which will bemade available, along with the details of the unsuccessful bidders, to ICICI Bank by the e-Procurement portal through web services.
ii. On receipt of the information from the e-Procurement portal, the Bank will refund, through anautomated process, the EMD of the bidders disqualified at the technical evaluation to therespective bidders' bank accounts from which they made the payment transaction. Such refundwill take place within $T+2$ Bank Working Days where T will mean the date on which information rejection of bid is uploaded to the e-Procurement portal by the Tender inviting authority.

General Terms & Conditions

- 1. Two part bid which consists of Technical & Financial bid separately.
- 2. The applicants must upload the credentials Statutory & Non Statutory documents in the Technical Folder. Nothing should be sent physically except the sample of each variant of containers.
- 4. The intending bidders are required to quote the rate online only. Financial Bid will contain rate of items only. No other document will be sent in the financial bid (Folder).
- 5. Bidder should quote unit price of the material inclusive of all taxes and levies, conversion cost, loading and unloadingF.O.R The Bhagirathi Cooperative Milk Producers' Union Limited. (Price should be based on Current price of HDPE granules + conversion cost). All taxes, levies, mould cost, printing of multi colour shrink wraps as per approved design, affixing, pigmentation, aluminum foils, transport, loading, unloading shall come under one head i.e. Conversion Cost.
- 6. EMD of the lowest successful bidder shall be converted to Security Deposit and shall be released after 2 months after successful execution of the contract.
- 7. Lowest bidder has to provide certified testing report from any recognized NABL certified laboratory which shall be duly verified by the Milk Union before issuance of Award of contract. If the lowest bidder fails to provide NABL lab certified testing report the bid shall be cancelled.
- 8. The intending bidder is required to quote the rate in figures as well as in words in financial bid. Rate should be quoted per piece of item.
- 9. Payment shall be made on receipt of quality report of the supplied materials from Requisitioning Authority & on submission of Bill in duplicate along with the received challans from the Competent Authority after examination of each lot in NEFT/RTGS within 30 days of supply of materials. Payment may be delayed if there is any discrepancy or performance issue from the end of the supplier. The supplier should clearly understand his financial capacity before bid submission.

- 10. The documents submitted by the bidders online should be properly indexed & digitally signed.
- 11. During the scrutiny, if it comes to the notice to the tender inviting authority that the credential(s) and/or any other paper(s) has/have been of any bidder found incorrect/ manufactured/ fabricated, that bidder will not be allowed to participate in the tender process and that application will be rejected outright. The Bhagirathi Cooperative Milk Producers' Union Ltd. Reserves the right to cancel the N.I.T. at any time without showing any reason and no claim in this respect will be entertained.
- 12. Supply of Goods: The goods must be delivered within delivery schedule which is 10-15 days from the date of Placement of Purchase Order. Materials ordered at a single Purchase Order must be sent in a single consignment. No materials shall be received in pro rata basis. The bidder should have the capacity to supply one third of the total quantity of annual requirement in a month. Bidder should clearly go through the tender document and understand this context before participating in the Tender. If in any case the bidder fails to adhere by this clause jeopardizing the material flow it shall invite penalty and subsequently the Contract shall be terminated and Security deposit shall be forfeited.
- 13. Packaging and Identification: The materials supplied should be packed properly and material quantity each pack should be clearly mentioned. Materials with improper packaging and identification shall not be accepted.
- 14. Time being the essence of contract no variation shall be permitted in the delivery time as prescribed in the delivery schedule. If the bidder fails to supply and execute the work in full or part of order as per delivery schedule, The Bhagirathi Milk Union Ltd. shall reserve the right to cancel the order besides forfeiture of Security Deposit.
- 15. One termination of contract, the Security Deposit is liable to be forfeited and any of the resultant loss beyond Security Deposit will be recovered from the contractor by deduction of the amount from bills or bylegal means apart from forfeiture of any amount due to the contractor.
- 16. If there is any complaint regarding non conforantion with quality/ damage / short supply / failure of schedule date delivery etc. the supplier will be responsible for replacement of the same or the cost of such item would be deducted from the bill amount, Security Deposit whichever applicable.
- 17. The Milk Union reserves the right to terminate this contract if your performance is found unsatisfactory.

- 19. Conditional *and* incomplete tender will not be entertained. Violation of one or more clause will result in rejection of the tender
- 20. The accepting authority (The Bhagirathi Cooperative Milk Producers' Union Ltd.) reserves the right to reject any or all the tenders without assigning any reason whatsoever and will not be bound to accept either the lowest tender or any of the tenders.

- 21. The Milk Union reserves the right to approve more than one supplier at L1 rate and it shall be termed as **alternate supplier**.
- 22. Before issuance of the SUPPLY ORDER, the tender inviting authority may verify the original credential(s) and/ or other document(s) of the lowest bidder with original documents, if found necessary. After verification, if it is found that the document(s) submitted by the lowest bidder is/are either manufactured or false, the work order will not be issued in favour of the said Bidder and security deposit will be forfeited.
- 23. The rate quoted by the bidder shall be inclusive of all taxes packing, forwarding, Excise Duty, loading and unloading& GST and other charges/ taxes if any for the delivery of the goods in the office of The Bhagirathi Cooperative Milk Producers' Union Ltd.
- 24. Mode of transportation, loading and unloading of goods will be arranged by the supplier and no claim in this regards shall be entertained. If in any cases loading and unloading is arranged by the Milk Union the subsequent cost shall be deducted from the bill.
- 25. The undersigned reserves the right to call a separate E-Tender by superseding this Tender at any time or cancel the tender or any bids at any point of time without assigning any reason thereof and no claim in this regard shall be entertained.
- 26. The Milk Union has the right to reject any party depending upon its poor performance in the past and no question in this regard shall be entertained.
- 27. Price Variation Clause: The Conversion cost includes All taxes, levies, mould cost, printing of multi colour shrink wraps as per approved design, affixing, pigmentation, design, packaging, aluminum foils, transport, loading, unloading shall come under one head i.e. Conversion Costwhich shall be fixed during the tenure of the Contract. The rates of granules shall be based on rate of HDPE Granule for B6401, and PP Granule for M110 or equivalent grade per MT (Any change of rate made by RIL/Haldia/Supreme/Equivalent at any time either upward or downwardshould be informed by the Supplier to the Managing Director, BCMPUL when the Purchase Order is placed. The Purchase Order shall be placed on the actual price of HDPE granules (RIL/Haldia/Supreme/Equivalent) + conversion cost of materials. During bidding the rate shall be based on the price* of HDPE granules + conversion cost.

28. Price* of HDPE B6401 and PP M110 may be taken as Rs. 70/- per kg inclusive of all during entering rates for Financial Bid.

Illustration of rate to be entered in tender:

If the bidder puts conversion cost of Rs 7/- for 1 kg, Rs. 5/- for 500 gm, Rs. 3/- for 200 gm and Rs. 2 for 100 gm inclusive of all, then total cost is Material Cost + Conversion cost. Total Cost inclusive of all has to be quoted by the bidder in BOQ.

SPECIFICATION OF GHEE CONTAINERS

- a. The HDPE containers and PP caps should be free from odour, cracks and free from dust/dirt inside.
- b. Containers should be properly threaded for screw cap fitting and the cap should be free from cracks and deformation.
- c. Foils supplied should be free from pinholes and must be suitable for heat sealing.
- d. Ghee containers and caps should be packed in separate polythene leakage proof linear and then into suitable bags.
- e. Material used for manufacturing container, cap and foil should be of food grade quality.

Technical Specifications

Body Material of the Ghee Containers must be Food grade virgin **High-density polyethylene** (**HDPE**) of B6401 equivalent grade and cap should be made of Food grade virgin Poly propylene (PP) of M110 or equivalent grade.Containers should be accompanied by printed Aluminum foils for sealing. The word "BHAGIRATHI" is to be imposed on the lid. The body shall contain shrink wrapped labels as per approved design of the milk union duly affixed by the supplier.

Bidders should strictly conform to the prescribed specification.
