8. **Packing:** The Materials shall be packed suitably for dispatch directly to Milk Union at supplier's expenses and supplier shall be responsible for any damage during transit.
9. **Payment terms:** Payment shall be made in NEFT/RTGS after 30 days of receipt of the bill along with the materials in good condition certified by Competent Authority.
10. Material received with manufacturing defect shall not be accepted. In case material does not conform to the acceptability standard of the Milk Union the material has to be replaced by the party within 7 days.
11. In case of any dispute between the Milk Union and the bidder the decision of the Milk Union shall be final and binding.
