The Bhagirathi Milk Union invites sealed quotations for **Anti-Termite Treatment** at the pre-construction stage of new store building having an approximate area of 5500sq ft in Bhagirathi Milk union campus as per **BIS 6313 (Part-2):2013** Code of Practice. Therefore, reliable, resourceful, and Bonafide firms/individuals/agencies/contractors with sufficient experience and expertise in pest control and anti-termite treatment are requested to quote their best rate.

Eligibility Criteria:

- Valid Pest control operator (PCO) license and (PMA) Pest Management Association valid membership.
- GST Registration certificate.
- Certificate of Enlistment/Trade License

Scope of work

The work shall include complete pre-construction chemical treatment against subterranean termites strictly in accordance with **BIS Standard IS 6313 (Part-2): 2013** and other relevant Indian Standards. The scope includes the following job:

- Treatment of Excavation/Foundations**
 - Bottom and sides of foundation trenches
 - Backfill treatment
- Treatment of Flooring Areas**
 - Plinth area treatment before laying sub-grade
 - Junction of walls and floors (Both).
- Treatment of soil along External Perimeter of Building**
 - Building perimeter trench treatment up to required depth and rate
- Chemical Requirement**

- Use only BIS-approved termiticides (e.g., Chlorpyrifos 20% EC, Imidacloprid 30.5% SC, Fipronil 2.5% EC, or equivalent) applied at recommended concentration and dosage as per IS 6313 (Part-2): 2013.

- Spraying, pressure pumping, and trenches as applicable
 - Uniform distribution of chemical without gaps
 - Safety and environmental compliance during handling, mixing, and application
- f. **Documentation**
- Submission of method statement, chemical details, safety data sheets
 - Work completion report.
 - 3 copies of Invoices

Estimated Area: Total plinth and structural treatment area: **Approximately 5500 sq. ft.**

General Terms & Conditions:

1. The bidders are required to go through the Terms & Condition carefully, understand the requirement and then quote the most competitive rate in sealed envelope addressed to the Managing Director, The Bhagirathi Cooperative Milk Producers' Union Limited, Feeder Dairy, Panchanantala, Berhampore, Murshidabad, 742101 (WB).
2. Quotation shall only be accepted in sealed envelope subscribing the Enquiry No. and Item Type. No quotations shall be accepted through mail. Incomplete quotations are liable to be rejected.
3. **Earnest Money Deposit (EMD):** EMD of **Rs.1000/-**
4. **Site:** The Bhagirathi Cooperative Milk Producers' Union Limited, Feeder Dairy, Panchanantala, Berhampore, Murshidabad, 742101 (WB).
5. Interested bidders may visit the site to understand the nature and extent of work involved before quoting their rates.
6. Ensuring clean and safe application of termite treatment and clear separation of treated and untreated zones.
7. It is mandatory for the bidder to adhere to the payment terms and other general terms and conditions specified in this NIQ. No price escalation will be entertained after the submission of bids.
8. **Cleanliness in the workspace:** The supplier shall ensure that the workplace remains clean and safe during the execution of work. Waste and leftover materials must be cleared after the completion of the work

10. Payment: Payment shall be made in NEFT/RTGS within 30 days after satisfactory completion of the job certified by competent authority.
11. **Warranty/Guarantee:** The contractor shall provide a **minimum 10-year guarantee** against termite infestation from the date of completion. Any recurrence during the guarantee period must be rectified at no extra cost.
12. Non-Conformation to standards: If the job done is not as per the scope of the Work or as per BIS standards payment shall not be released to the contractor.
13. In case there is any discrepancy the Milk Union may impose a penalty or reject the job. The subsequent company shall be blacklisted for 3 years.
14. In case any dispute between the supplier and Milk Union the decision of the Milk Union will be final and binding.
15. The Milk Union reserves full right to accept or reject any quotation/all quotations or to cancel the entire process at any point of time without assigning any reason thereof.
