- 1. - 2. Quotation shall only be accepted in sealed envelope subscribing the Enquiry No. and item type. No quotations shall be accepted through mail. Incomplete quotations are liable to be rejected.
- 3. Quotation received after DUE DATE & TIME will not be considered. BCMPUL shall not be responsible for delays in postal transit.
- 4. Price quoted by the bidder should be inclusive of all taxes levies packing, and forwarding F.O.R The Bhagirathi Cooperative Milk Producers' Union Limited and in adherence to the payment terms and other general terms and conditions enshrined in this NIQ. No escalation in price will be considered after submission of bids.
- 5. The bidders participating in the quotation must provide the following Mandatory Documents along with the price bids:

- a. Copy of NIQ duly signed and Sealed as a token of acceptance of all terms and conditions in the NIQ.
- b. GST Registration Certificate.
- c. Rate must be quoted by Bidder as per above table.

Failure to submit the above mandatory documents shall lead to rejection of the Quotation

- 6. **Tentative Delivery/Supply Schedule:** Materials must be delivered within 7 days after placement of Purchase Order.
- 7. The quotation should be complete in all respects and the firms shall give the Make/Brand name offered for the items in the quotations. Wherever applicable, technical literature may please be enclosed along with quotation.
- 8. **Warranty:** Material/ equipment shall be warranty for the minimum period of 3 years from the principal Company with technical support and shall be warranty on-site for satisfactory performance, workmanship and for the quality of material/ equipment supplied by the firm from the date of delivery.
- 9. **Packing:** The Materials shall be packed suitably for dispatch directly to Milk Union at Suppliers expenses and supplier shall be responsible for any damage during transit.
- 10. **Service**: The offer shall clearly state full details of the after-sales service facility available for the equipment.
- 11. **Payment terms:** Payment shall be made in NEFT/RTGS after 30 days of receipt of the bill along with the materials in good condition certified by Competent Authority.
- 12. **Liquidated Damage:** If a firm accepts an order and fails to execute the order in part or in full, as per the terms and conditions stipulated in the Purchase Order, it will be open to the institute to recover the liquidated damages from the firm at the rate of 0.5% per week of the order value subject to a maximum of 10% of the order value.
- 13. The material received if found to be of substandard quality shall be rejected upon mutual inspection. In case material does not conform to the acceptability standard of the Milk Union the material has to be replaced by the party within 7 days.
- 14. In case there is any discrepancy in quality the Milk Union may impose a penalty and then accept the goods. In this case prior intimation shall be given to the supplier.
- 15. In case of any dispute between the Milk Union and the bidder the decision of the Milk Union shall be final and binding.

The Milk Union reserves full right to accept or reject any quotation/all quotations or to cancel the entire process without assigning any reason thereof.
