- 1. The bidders are required to go through the Terms & Condition carefully, understand the requirement and then quote the most competitive rate in sealed envelope addressed to the Managing Director, The Bhagirathi Cooperative Milk Producers' Union Limited, Feeder Dairy, Panchanantala, Berhampore, Murshidabad, 742101 (WB).
- 2. Quotation shall only be accepted in sealed envelope subscribing the Enquiry No. and Item Type. No quotations shall be accepted through mail. Incomplete quotations are liable to be rejected.
- 3. Price quoted by the bidder should be inclusive of all taxes levies packing, and forwarding F.O.R Feeder Dairy, Berhampore, Murshidabad and in adherence to the payment terms and other general terms and conditions enshrined in this NIQ. No escalation in price will be considered after submission of bids.
- 4. The bidders participating in the quotation must provide the following Mandatory Documents along with the price bids:
  - a. Copy of NIQ duly signed and Sealed as a token of acceptance of all terms and conditions in the NIQ.
  - b. GST Registration Certificate.
  - c. Rate as per format in FORMAT A.

Failure to submit the above mandatory documents shall lead to rejection of the Quotation.

- 5. The job must be completed within 10 days after placement of Work Cum Supply Order.
- 6. Payment shall be made in NEFT/RTGS within 30 days after satisfactory completion of the job certified by competent authority.
- 7. In case there is any discrepancy in quality of job the Milk Union may impose a penalty. In this case prior intimation shall be given to the supplier.
- 8. In case of any dispute between the Milk Union and the bidder the decision of the Milk Union shall be final and binding.
- 9. The Milk Union reserves full right to accept or reject any quotation/all quotations or to cancel the entire process without assigning any reason thereof.
